With this information the Council maps out the required monies for standing costs and projects for the following year and applies specific figures to budget headings, the total of which is resolved to be the precept amount to be requested from East Hampshire District Council. This figure is submitted by the Clerk in writing to EHDC by the date indicated.</p> <p>Precept should be considered by Council before the deadline - deadline should be ascertained from EHDC if not notified by the end of December.</p> <p>The Clerk informs Council when the monies are received (April and September).</p>	Existing procedure adequate
