Thank you for your email and apologies for the delay in responding.

As a Parish Council is a statutory body with statutory functions they cannot be classed as a 'not for profit' organisation. A Parish Council would usually register as they are processing data for the provisions of local services, also campaigns, public relations and fundraising, and the maintenance of a website, which can include advertising and marketing for others, all of which are purposes of data which are not exempt from registration. If they are processing data electronically, including word processing they would be unable to rely on the exemptions and therefore be required to register. If all data is held manually they would be exempt from registration.
