TI- Yew by garage to be reduced away from the roof to give clearance of Im to protect tiled roof and have a crown reduction by 1.5m to leave canopy radius height of 8.5m with final measurements of N4,E5,S4,W4m.

T2- Yew- Rebalance tree. Height to be reduced back into canopy by 0.5-1m. Most of the rebalance is off the South side from 5.8m to 5m and crown clean.

T3- Yew- North Aspect reduction from 6m to 4m.

T4- Yew- Dead wood suppressed specimen underneath the Sycamore trees.

T5- Yew- Reduce south stem down from 15m to 13m to marry up with the rest of the canopy. Slight tip reduction where necessary.

T6- Yew- Height reduction from 12.4m to 9m to blend back into the canopy line.

T7&8- Sycamores - Crown Clean and deadwood.

T9 - Tree Group -Tree line along the road- 2 Sycamores, I Ash, I Beech and 2 more Sycamores along road side to be crown lifted, but tip reduction to 4.5m. All garden side to allow hedge row light to grow. Only one Sycamore at the northern end needing I branch reduced from the roadside.
